**Professor Tang Hang Wu**Professor, Singapore Management University

In addition to his academic work, he been instructed as Counsel or expert witness by Singapore and international law firms on complex property and trust disputes. Hang Wu also advises trustees in relation to trust structures and decision-making and has experience managing trust disputes in Singapore and Jersey.
